FEES AND CHARGES BYLAW

BYLAW NO. 2021-005

NOW THEREFORE, the Capital Region Northeast Water Services Commission, in the Province of Alberta, in open meeting of the Commission duly assembled enacts as follows:

1. That this Bylaw may be cited as the Fees and Charges Bylaw.
2. That the Fees and Charges Manual attached as Schedule "A" to this Bylaw represents the fees, rates and charges established by the Board and are applicable to the Capital Region Northeast Water Services Commission services provided by the Commission as outlined herein.
3. That if there are any inconsistencies between the fees, rates and charges imposed pursuant to this Bylaw, and those imposed by any other Bylaw or Policy of the Capital Region Northeast Water Services Commission, this Bylaw shall take precedence.
4. This Bylaw comes into force and effect on June 14, 2021.
